Those projects are the 3300 North continuation and the 1740 West extension. Mayor Phippen stated he attended the N.U.T. held by the Trails foundation at North Fork. He stated there is RAMP training on October 23rd that he

and Katie Williams will be attending. Mayor Phippen reported the Legislative Policy Committee is still addressing moderate income housing, but now asking what the cities are doing about starter homes. Mayor Phippen reported on the Public Infrastructure District meeting and stated there are opportunities there for developers to get funding for infrastructure.
