

ORDINANCE NO. _____

**AN ORDINANCE OF FARR WEST CITY, UTAH AMENDING TITLE 2 OF THE
FARR WEST CITY MUNICIPAL CODE AND PROVIDING FOR THE
COMPENSATION OF ELECTED AND STATUTORY OFFICERS**

WHEREAS, the number of duties assigned to each elective officer has increased significantly and each elected officer is required to devote more time to the effective administration of Farr West City; and

WHEREAS, public service obligates elected officers to spend their own money in the service of the city, and

WHEREAS, the Farr West City Council finds that elected and statutory officers should be fairly compensated for their time and expenses;

NOW THEREFORE, it is hereby ordained by the Farr West City Council that Title 2 of the Farr West City Municipal Code be amended as follows:

Section 1. All previous salary or compensation ordinances regarding elected and statutory officers of Farr West City are repealed as of July 1, 2016 and Chapter 2.24 of the Farr West Municipal Code is deleted in its entirety as of July 1, 2016.

Section 2. A new Chapter 2.24 is adopted to read as follows:

Chapter 2.24

COMPENSATION OF ELECTED AND STATUTORY OFFICERS

2.24.010 COMPENSATION FOR ELECTED OFFICIALS

A. Compensation for all elected officials of the city shall be fixed according to the following schedule:

Mayor	\$1,000.00 per month
Council Members	\$ 400.00 per month

B. The Mayor and the city council may accept compensation or remuneration from other boards, councils, committees or commissions on which they serve as part of their official

duties as a Farr West council member.

C. An amount equal to the current federal requirements for social security and Medicare will be deducted.

D. The position of mayor shall be given a vehicle, fuel and cell phone allowance in the form and amount as set by the Farr West City Council.

E. The salaries and benefits set by this ordinance shall be effective July 1, 2016.

2.24.020 COMPENSATION FOR STATUTORY OFFICERS

Compensation for all appointed officers of the city shall be fixed according to the following schedule, with the exception of the City Recorder:

Recorder	Compensation set by employee wage scale
Treasurer	\$1,200.00 per month
Justice Court Judge	\$ 974.00 per month
Attorney	\$ 100.00 per month retainer + \$50.00 per hour

2.24.030 COMPENSATION PAYMENT AND ADJUSTMENTS

A. Payment. The Treasurer shall pay each elected and statutory officer on the last regular business day of each month by delivery of a check drawn on the municipal checking account to the elected or statutory officer personally or by mailing the check to the elected or statutory officer at his or her home, postage prepaid.

B. Per Diem. Each member of the governing body shall receive mileage and per diem for all trips approved by the government body according to the schedules adopted by the Utah Department of Finance.

Section 3. This ordinance shall take effect upon its adoption and publication or posting by the City Council of Farr West City, Utah this _____ day of _____, 2016
