## AN ORDINANCE OF FARR WEST CITY, UTAH AMENDING TITLE 5, TITLE 15 AND TITLE 17 OF THE FARR WEST CITY MUNICIPAL CODE

**WHEREAS**, the Farr West City Council finds it is necessary to revise Title 5, Title 15 and Title 17 of the Farr West City Municipal Code.

**NOW THEREFORE**, it is hereby ordained by the Farr West City Council that Title 5, Title 15 and Title 17 of the Farr West City Municipal Code be amended as follows:

**Section 1.** Chapters 5.04.080, 5.20.010(A) and 5.20.020 paragraphs A, B, D & E of Title 5 of the Farr West Municipal Code shall be amended to read as follows:

**5.04.080: LICENSE FEE**: An applicant shall, upon filing his or her application for a business license, deposit with the city a fee prescribed by resolution for the business, trade, profession, occupation or calling for which a license is applied as published in the fee schedule codified in Title 3, chapter 3.30 of this code. Application for a business license made prior to July 1 shall pay the full fee. Applications made on July 1 through December 31 shall pay one half of the prescribed fee. The city shall provide the applicant a receipt for the fee payment, but such receipt shall not be deemed to be a certificate of license. In the event the license application should not be approved by the city council, the fee paid shall be refunded to the applicant. All license fees shall be payable annually, in advance (unless otherwise provided).

## 5.20.010: PROHIBITED WHEN:

A. It is unlawful for any person to call at the residence of any other person for the purpose of soliciting or taking orders, sale, barter, exchange, delivery of any goods, wares, or merchandise on any Saturday, Sunday or holiday. Soliciting is prohibited between the hours of 8 P.M. and 9 A.M. This chapter shall not apply to any person who was previously invited by the householder to come to such residence for any of the foregoing purposes.

## 5.20.020: LICENSE REQUIRED; BOND:

- A. 6. Provide a current (within 6 months) Bureau of Criminal Identification (BCI) background check for all solicitors.
- B. Current Photos: Furnish the city with two (2) photographs not larger than two inches by three inches (2" x 3") of the applicant taken within the last twelve (12) months. One shall be affixed to the license in the files and records of Farr West City; the other will be used as photo identification that is to be worn in plain sight by the solicitor.

- D. Deposit: Submit a corporate surety bond conditioned upon the observance of all laws and ordinances of the city and license conditions agreed to by the licensee. The amount of such bond shall be established and listed in the Farr West City fee schedule;
- E. License/Photo: The license must be kept on the solicitor's person at all times. The photograph must be visible and in plain sight while soliciting is being conducted. The license must be presented upon the demand of any person.
- **Section 2.** Chapters 15.22.050(D) of Title 15 of the Farr West Municipal Code shall be amended to read as follows:

## 15.22.050: STORMWATER UTILITY FEE:

- D. Charge per ERU: The storm water utility fee as established by the city council is codified in Title 3, chapter 3.30, "Fee Schedule", of this code.
- **Section 3.** Chapters 17.12.020(G) of Title 17 of the Farr West Municipal Code shall be amended to read as follows:
  - G. All applications, including applications for rezoning, conditional uses, and site plans filed with the city recorder shall be accompanied by payment of the fee for each application as established by the city council and codified in Title 3, chapter 3.30, "Fee Schedule", of this code.
